Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2024 of **Llangedwyn Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of Qualification

Accounting Statement

I am unable to conclude whether or not the Accounting Statement properly/fairly presents the Council's receipts and payments/income and expenditure and financial position:

- The council has not provided adequate explanation of variances between the current and prior years.
- Line 9 cash and investments excludes unrepresented cheques


Other matters and recommendations

Information required for audit

Each year we send to the Council an audit notice. This sets out the information required for the audit and a timetable for the submission of

the annual return and supporting documentation. This year, the Council did not provide all of the information required for the audit. As a result additional time was spent chasing the information and this has resulted in additional audit fees being charged.
